Privacy watchdog slam growing database

Seven provincial privacy commissioners have fired off a letter to Revenue Minister Elinor Caplan disapproving of the federal government's plan to expand a database that stores details of the air travel of Canadians.

Having previously expressed their concerns to the federal government, the commissioners said they are particularly worried about the plan to "expand the database even further to include personal information on individuals who arrive in Canada by other means, such as trains, ships and buses".

Colette Gentes-Hawn, spokeswoman for the Canada Customs and Revenue Agency in Ottawa, said there are no plans to make immediate changes.

"There is nothing concrete yet," Ms. Gentes-Hawn told globeandmail.com on Wednesday, adding the earliest changes might be implemented would be 2004.

It still has to be determined how federal officials could collect information from people travelling, for example by bus. When you buy a bus ticket you don't have to give your name whereas if you travel by ship you do, she said.

The Canada Customs and Revenue Agency's database is "overly broad and unnecessarily targets innocent Canadians for surveillance by the state", the commissioners said in their letter.

The letter is signed by privacy commissioners or representatives in Ontario, Alberta, British Columbia, Manitoba, Saskatchewan, Nova Scotia, and the Northwest Territories and Nunavut.

When the database was publicly announced in September, Ms. Caplan maintained that it would be a powerful weapon in the war against terrorism and will help catch criminals and tax cheats. But the announcement raised concerns from the civil liberties groups as well as federal privacy

But the announcement raised concerns from the civil liberties groups as well as federal privacy commissioner George Radwanski.

"The information contained in the database can be used for purposes unrelated to anti-terrorist security". "Rather than collecting and retaining the personal information of a small number or targeted air travellers, as originally planned, the database is far greater in scope and now is slated to expand," the letter says. Canada Customs was given the power to collect the information from airlines in antiterrorism legislation passed after Sept. 11, 2001 terrorist attacks. The Liberal government had insisted the data would only be used to check incoming passengers for criminal records or terrorism threats and would be destroyed within 24 hours.

But customs officials informed Mr. Radwanski in June that all information on air passengers would be kept in a computer database for six years. The privacy commissioner argues the database will violate the Privacy Act and Charter of Rights and Freedoms.

The provincial privacy commissioners echoed the concerns of their federal counterpart saying they are worried that the RCMP will be allowed to use passenger information for general law enforcement, not just national or aviation security.

While acknowledging the heightened security concerns, they said that the fight against terrorism "cannot be used as an excuse to expand the powers of the police or other agencies of the state, for other purposes." They have asked the Revenue Minister to reconsider the initiatives and have asked for a response to their letter.
